**GROOMIN N ROOMIN'S DOGGIE DAYCARE CONDITIONS & TERMS:**

1. I understand and agree that in admitting my dog(s), Groomin N Roomin's Doggie Daycare has relied on my representation that my dog(s) have not harmed, shown aggression or displayed threatening behavior towards any person or other dog, and are in good health, with no communicable diseases.
2. All pets that are cared for by Groomin N Roomin's Doggie Daycare without liability on their part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care having been exercised.
3. If the pet becomes seriously ill or injured, the owner will be notified at once. If the owner doesn't inform immediately regarding measures to be taken, or if the state of the pet's health reasonably demands quick action Groomin N Roomin staff have the right to call a veterinarian or to take the pet to a veterinarian; We may use the veterinarian designated above, or if no veterinarian is designated we may use one of our choice. Groomin N Roomin may administer medicine or give advisable attention, within the staff's discretion and judgment. All such expenses, being reasonable in amount shall be paid promptly by the owner of the pet.
4. I certify that my dog is not a "dangerous dog" or "vicious animal".
5. I also understand that I am solely responsible for any harm or damage that may occur caused by my dog(s) and will take full financial responsibility while he/she is in attendance at Groomin N Roomin's Doggie Daycare. I also understand and agree that Groomin N Roomin's Doggie Daycare and their staff are not liable for any problems that develop arising from my dog(s) attendance at the daycare or the swimming pool.
6. I also understand that problems that may occur with my dog(s) will be dealt with in the best possible way at the discretion of the staff of Groomin N Roomin's Doggie Daycare.
7. I also understand that a copy of my dog(s) most recent medical and health records will be kept on file and such records must have veterinarian cortication prior to admittance to Groomin N Roomin's Doggie Daycare. Copies of medical and health records must be updated within 30 days of dog(s) veterinarian visit.
8. Groomin N Roomin's Doggie Daycare reserves the right to deny and/or refuse re-admittance to any dog that does not meet our health, behavior, and insurance requirements.
9. I understand that my dog's behavior and that of other dogs present at Groomin N Roomin's Doggie Daycare may be unpredictable. I hereby assume any and all risks involved in my presence at and my dog's acceptance into Groomin N Roomin's Doggie Daycare. I further release and agree to defend, indemnify and otherwise hold harmless Groomin N Roomin's Doggie Daycare and any subsidiary, parent, trade name or affiliated company, directors, officers, employees, and their agents, servants, successors, heirs, executors, administrators and all other persons, corporations, firms, associations or partnerships from any and all claims arising out of my dog's conduct or any damages or injuries caused or sustained by my dog or myself.
10. This Policy Agreement and Release shall apply indefinitely and during the course of each and every visit I and/or my dog make to Groomin N Roomin's Doggie Daycare.
11. I understand that Groomin N Roomin's Doggie Daycare may make modifications to this Policy Agreement and Release and that I, from time to time, may be asked to sign a revised Policy Agreement and Release. I understand that, while I am under no obligation to do so, my refusal to sign a revised Policy Agreement and Release will result in Groomin N Roomin's Doggie Daycare's refusal to accept my dog in the future.

**GROOMIN N ROOMIN'S GROOMING CONDITIONS & TERMS:**

1. The animal is fit and healthy. Any grooming which takes place on an elderly animal or an animal with health problems will be at the owner's risk. Grooming may expose pre-existing health/skin problems for which the company cannot be held liable.
2. The animal is vaccinated up to date. Any unvaccinated animal puts itself and others at risk.
3. In the event of an injury or health concern, we are authorized to contact a veterinarian to treat the pet as necessary.
4. Dematting hair may cause patchiness and hair loss. Consent to remove the matted hair is on this understanding.
5. All pets groomed/bathed or otherwise cared for by me without liability on my part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes due diligence and care having been exercised.
6. Payment will be made at time services are rendered.
7. Shaving/Stripping of pets will dramatically change the pet's appearance and the hair will be very close to the skin. This may expose pre-existing skin complaints. Your written permission will be required to perform this service.

**GROOMIN N ROOMIN'S KENNEL CONDITIONS & TERMS**

1. I agree to exercise due and reasonable care and to keep my kennel premises sanitary and properly enclosed. The pet is to be fed properly and regularly, and to be housed in clean, safe quarters.
2. All pets are boarded or trained, or otherwise cared for by me without liability on my part for loss or damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care having been exercised.
3. If a pet, which is presented for boarding, is found to have fleas and/or ticks, it will be bathed at the owner's expense.
4. The pet is not to be taken off the premises except by the consent of the owner.
5. If the pet becomes seriously ill, the owner shall be notified at once in case no particular veterinarian has been designated. If the owner does not inform immediately regarding measures to be taken, or if the state of the pet's health reasonably demands quick action, I shall have the right to call a veterinarian, as designated above, or if no veterinarian is designated, to call a veterinarian of my own choice or take the pet to said veterinarian in either case, or administer medicine or give advisable attention, within my discretion and judgment, and such expenses, being reasonable in amount shall be paid promptly by the owner of the pet.
6. If any charges for boarding, grooming, training, medicine, or veterinary services are not paid within ten days after they are due, or if a pet is not called for within ten days after time of return of pet, the pet will be sold within ten days after this period by me publicly, privately, or otherwise for the best price available. Notice in writing of such intended sale shall be mailed by registered mail to the owner of the pet at the address given hereon, no less than ten days before date of such intended sale, and no further notice shall be deemed necessary. Any excess amount over charges will be given to the owner, while any deficiency is deemed to be due and immediately paid by the owner.
7. We are not responsible for lost/damaged personal belongings.

**TERMS FOR BOARDING TWO OR MORE PETS TOGETHER:**

1. I hereby agree to the foregoing as the owner of the pets that my dogs are being boarded together in the same kennel with my consent.
2. I agree as the owner of the pet that Groomin N Roomin will not be held liable for any aggressive behavior, fighting or injury that one dog may inflict upon another while they are together. Groomin N Roomin reserves the right to separate any dogs boarding together at our discretion for their own safety.
